An important change to the release of this qualification was the introduction of mandatory entry requirements specifying an individual must have either the CHC30121/CHC30113 Certificate III in Early Childhood Education and Care.</p> <p>This entry requirement does not recognise any previous versions of the Certificate III and/or equivalent qualifications.
